CLIENT FAMILIES CAN COME TO THE STORE, AS NEEDED, FOR SHOPPING. IN ALL, THERE WERE 1,843 VISITS TO THE STORE AND 42,395 ITEMS WERE DISTRIBUTED. IN DECEMBER 2021, 176 FAMILIES RECEIVED GIFT CARDS TO SHOP FOR GROCERIES FOR A HOLIDAY MEAL SERVING 4-6 PEOPLE THROUGH OUR CHRISTMAS MEALS PROGRAM. THE GIFT CARDS WERE PROVIDED THROUGH MONETARY DONATIONS FROM MEMBERS OF THE COMMUNITY.
